Membership Q & A

Everyone has questions about dues, sponsoring new members, how long it takes to be voted on, etc.

Dues are due every January 1. No matter what time of year you joined CSAR, dues are still due Jan. 1. If not paid by March, a reminder letter is sent out. If still unpaid 90 days later, you are considered lapsed and are dropped. If that happens, you must reapply for membership to CSAR.

Who can sponsor a new member? A new standing rule was adopted by the CSAR membership in Oct. 2002 stating that a sponsor must be a member in good standing for at least a year before sponsoring new members.

How long does it take to get voted into membership? This time frame may vary from a few weeks to a few months, depending on when a membership application is received. The prospective member's name will be published in the next CSAR newsletter for the entire membership to be aware of proposed new members. After a 30 day comment period, the Board of Directors will vote on the proposed new member.

What if I don't have a sponsor? We will try very hard to put an interested applicant in touch with a current CSAR member in their area. However, that is not always possible and a letter of recommendation from their agency on official letterhead or a resume of their SAR involvement can be substituted for a sponsor.

Don't forget the CSAR website: www.csar.org. There is also a CSAR Yahoo! Group. I have tried to make sure I send a Yahoo group "invite" to members as applications have come in. If you are interested in the Yahoo group, go to: <http://groups.yahoo.com/group/csarK9> to sign up, or again, contact me and I will send you the "invite" and you can sign up that way.

April 25, 2010

Previous meeting minutes. Handled/approved via email. All ayes.

Treasurer's report –

Rick Myers emailed a detailed copy of the Treasurer's Report in PDF format to all board members prior to conference call. Total value of all accounts is approximately \$37500. Rick confirmed that he does now have full access to all CSAR accounts. Rick Myers made a motion to move the extra seminar money from one account to a 1 year Certificate of Deposit bearing 1.25% interest. Janet G. 2nds. All ayes. Rick reported on money currently designated for the Carolyn Knapp Memorial Scholarship Fund and the designation of the money from the raffle at CSAR 2009. Rick motioned to move additional \$250 from the general fund to the Carolyn Knapp Memorial Scholarship Fund. Mike B. 2nds. All ayes.

Committee Reports:

Membership Committee (Terri)

Terri reported that members reported in the February newsletter have met their 30 day comment period with no negative comments. Linda U. motions that all new members presented be accepted. Rick M. 2nds. All ayes. Terri reported that she would be e-mailing all members currently not renewed for 2010 as a reminder. Then, following the e-mail, she will be sending a reminder via USPS to all non-paid members.

Terri reported that she will be publishing the next newsletter mid- to late May.

Following the April Board of Directors meeting, and email discussion was held by the Board establishing the Carolyn Knapp Memorial Scholarship Fund starting with a \$1000 donation CSAR received from an outside philanthropic source. Darcy H. made a motion via email for establishing the fund as follows:

Carolyn Knapp Memorial Scholarship Fund

Will be funded from dedicated donations made specifically to the fund. The fund will pay for one person to attend the CSAR Seminar every calendar year as long as there is enough money in the fund. If money is not available, there will be no award until the fund has money available from additional donations. The scholarship will pay the CSAR Seminar fee in its entirety (CSAR Rate/Discount) for one person. It will not pay for gas/lodging or food for the trip to the seminar. To apply for the fund, an individual must be 18 years of age, a member of CSAR for at least one full calendar year and must apply using the appropriate form. The selection of an award will be made based on financial need, the person's commitment to canine SAR and the person's commitment to CSR (i.e. length of membership/attended seminars before). The Awards committee will be responsible for the application, application review and selection of the scholarship awardee. The applications for 2010 will be due by June 30th and an application selected by July 31st. (dates can move depending on seminar dates)

Rick M. 2nds the original motion but added that the monies received from the raffle held at the 2009 CSAR seminar be added to the \$1000 seed money. All ayes

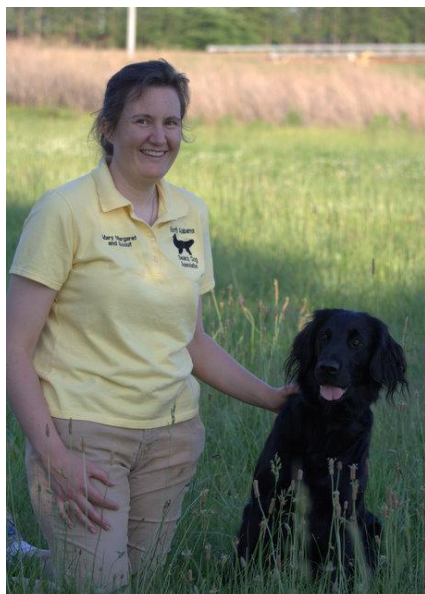
9. Something folks might not know about you.

Lessons Learned

We always say that hind site is 20/20 and most of our lessons learned in SAR come from hard work by training, reading, attending seminars, networking and actual searches. No matter how hard I work at this and no matter how many years I have been involved in SAR, I still find that most of my knowledge comes from real search experience. As prepared as you think you may be, there is always something that just does not go as smooth as it did in training.

We have two veterinary technicians on the team that are always well prepared in the event a canine medical emergency arises. So we thought. We always have a vehicle fairly close to the scene that is well stocked with supplies and ready to transport if needed.

Many of the searches my team is dispatched for are usually in urban/suburban type settings, some wooded areas such as forest preserves and similar wooded sites. Most of our searches are for HRD detection, missing suicidal and of course the most difficult the missing Alzheimer/dementia person. The Alzheimer person is what this particular search started out all about. It ended up being more of lesson learned by the handler and her K9 partner.

The search scenario: Oct. 22nd missing female/alzheimers/66yrs old/walks daily. The subject leaves her home and does not return.

The search callout: Oct 23rd and starts out with trailing dogs working from the subjects residence. Sightings were being called in from residents in the next town over so additional dogs and handlers were sent out in attempt to pick up trails and clear areas near the sightings.

Each handler was assigned to clear specific areas. I was working large residential lots with very thick woods between homes. My dog was working off lead not far ahead of me working the edges of the woods when I thought I heard noise in the wooded area. I turned into the woods, climbed over a pile of deadfall and then called my dog in to check the area. She came in after me over the same pile of deadfall, she let out a little yelp as she cleared the pile, she came and stood next to me for a minute and at that time I was going to send her back to work which she was more than willing to do. I was thinking she had just stepped on something. Thank goodness that somebody was watching over us because at this time I leaned over my dog and glanced underneath her to see a good size piece of a branch sticking out from somewhere underneath her. The dog showed no pain and was there ready to go back to work if I had told her to.

I immediately held on to her collar and tried to assess the situation better but could not because of the thick woods. I radioed in that I had an injured dog and needed assistance and to bring my vehicle to the area. I slowly walked her out of the woods into a clearing so that I could evaluate her condition. My partner had impaled herself on branch that had splintered as she jumped over it. I could see about 3 inches of wood sticking out of the inside of her back leg. Not knowing how much was actually in her and what was involved, I just knew not to pull it out. But how would you wrap something like this? Because of the position of the wood there was no way to bandage it without moving it. There was no way for one person to transport her by themselves, she could not lay or sit down without causing more damage. She needed emergency veterinary care as soon as possible.

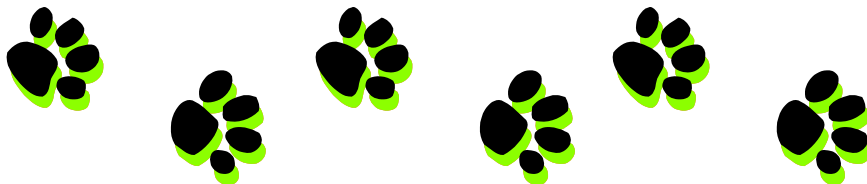

Teammates and police officers gathered around to see if they could help in anyway. One officer who was familiar with the subdivision mentioned a veterinarian living near by. Minutes later the veterinarian was at the scene. He agreed that wrapping would be difficult and transport also difficult but she needed to get into surgery immediately. Transportation was done with his car, handler sitting in the back seat and K9 straddled over me so I could prevent her from sitting or downing and making matters worse. He drove us to his clinic and immediately prepped her for surgery to remove the section of branch. The section of wood was 1 inch x 7 inches in length. It had threaded it self in her upper inner thigh along the femoral vein and the tip close to exiting out near her vulva. It was long and dirty. She was very fortunate. A large incision was made to remove it, it was cleaned and drains were sewn in place. After all other medical care was taken and she started to wake the Vet drove us back to my vehicle and the search scene. He refused any payment for his services. He was on the phone with my regular vet before I walked through the door the next morning. What a kind and caring soul this man was.

My team has been in existence since 1986 and this is the first serious injury to a canine on the team. Thankfully my K9 recovered from this incident. A split second decision to put her back to work would have changed the story. It can happen to any of us or our partners at anytime no matter how careful and prepared we think we are. Lessons Learned: Safety for us and our K9 partners are always the number one concern when out in the field. Be as prepared as you possibly can since you never know what to expect. Always think before acting. Never underestimate the kindness of a stranger. There are still a lot of good caring people in this world.

By the way, our Alzheimer victim was found the next morning off a main road in the ditch by a bloodhound and handler in good condition.
